Cannon Ríver and Cross of Christ Lutheran Parísh, ELCA

Before you speak, let your words pass through three gates: At the first gate, ask yourself "Is it true?" At the second gate ask, "Is it necessary?" At the third gate ask, "Is it kind?" -Rumi

Among the roiling currents of culture and discourse these days is the conversation on the nature of speech itself. What is free speech? What are its limits, if any? What of cancel culture? When has policing speech gone too far? What kind of speech legitimates shunning a person and their voice from public discourse perhaps on a permanent basis?

These are difficult questions that, if we are honest, evade clear cut answers. I certainly have my thoughts and opinions and I'm willing to bet you do as well. However, I think lost in these conversations about what we *can* say is the opportunity for a conversation about what we *should* say and *how* we should say it.

The quote above comes from an Islamic mystic from the 13th Century called Rumi. I think of this quote often when I am gearing up for hard or challenging conversations. They are good words to live by if we can. In our hyper polarized culture and a world of instantaneous connectivity his words become even more relevant. In our speech both public and private we should allow that speech to pass through these three gates.

- 1. Is what I am about to say **true**? Did I fact check the meme? Is it a fair characterization of a person's motives and goals? Am I contributing to the spread of misinformation even unintentionally just because what I want to say sounds or feels true?
- 2. Is what I am about to say **necessary**? Why am I choosing to speak? Will it be helpful or illuminating? Will it positively contribute to the discourse or add something of value to the conversation? Am I saying something just to be hurtful or rub something in?
- 3. Is what I am about to say **kind**? This is not to say we cannot speak hard truths to one another. After all we hear in the book of James to "speak the truth in love". We are not to shy away from criticisms or things that might be difficult for someone to hear. However, we should do it in a way that does not involve spite, character assassination, or personal (ad hominem) attacks that are not relevant to what we are trying to communicate. Is what I am saying for the good of my audience whether of one or many?

This framework is worthy of our consideration in these days in which fruitful and respectful conversation can be challenging to put it mildly. Our own Martin Luther of course was no stranger to this. Yet he knew it was essential to curbing sin and harm. He puts the task of true, necessary and kind speech this way in his explanation of the 8th commandment barring false witness levied against our neighbor:

We should fear and love God so that we do not tell lies about our neighbor, betray him, slander him, or hurt his reputation, but defend him, speak well of him, and interpret their actions in the best possible light.

We would also do well in all of this to remember also the words of Paul to the church at Corinth: "All things are permitted," but not all things are beneficial. "All things are permitted," but not all things build up. (1Corinthians 10:23). Just because we **can** say a thing does not mean that we *should*. What is lawful and what is right does and should overlap and it often does, but not always. Life is hashed out in hues of gray.

As we enter the season of Lent, a time of somber reflection on our actions and inactions we would do well to "take up" this practice of gated speech rather than "give up" chocolate or caffeine or to attempt a hard reset on a new year's resolution. Blessings on your Lenten journey in the coming months and the renewal of Easter beyond.

OLD BUSINESS:

Tracie sent me an email with the figures below:

"Your donation to Feed My Starving Children will provide **1,509 life giving meals** and Hope for individuals all around the world. Thank you for your generosity and compassion."

Total meals provided = 3,060 Kids fed for a year = 8

During our discussion, Tracie read a note that they received from Ivan in the Ukraine; I have included it below.

"Here is a copy of the note I read to you this morning from Ivan. When you think about it, he had no electricity at his house and yet was somehow able to get us this thank you, which I believe arrived via email. That is part of what moved me so much when I read it. He chose gratitude amidst all the chaos that must be going on in his life."

"I got a pack of your rice and I made soup out of it. I would like to thank you for what you are doing. This pack has come a long way to me ... I ate soup and thought why some people send us missiles and want to kill us, while other people send us food and want to support us. Both of them do not know me personally, but thanks to one I have no electricity but I have the threat of freezing in winter, and thanks to others I can eat delicious soup ... I want you to know that your efforts are getting there, even if you don't see the millions of people eating your rice. God bless you for your deeds!"

What is Cherish All Children? It is a ministry of Lutheran Social Services to educate, equip, and engage churches and communities to prevent child sexual exploitation and trafficking. LSS works throughout the state, including the Southeastern Minnesota Synod. Resources for churches include: a four-session series for middle and high school youth groups; a four-session series for congregations on ways to prevent child exploitation; presentations offered to youth and confirmation groups, and to adult forums and groups; a weekly Wednesday Prayer and email update for action-oriented and hope filled messages.

The Cherish All Children website (cherishallchildren.org) states: "The heart of this ministry lies in churches where staff, leaders and members work together to act on behalf of children and youth. . .. Faith communities are powerful agents for social change, and we invite you to join us in protecting all God's children.

Our Primary Prevention Model shows how we will work with your community, to stop the harm before it occurs. We: EDUCATE youth and adults about child sexual exploitation and trafficking and how to prevent it. EQUIP churches and communities with resources to prevent child sexual exploitation and trafficking. ENGAGE youth and adults to create a culture that promotes healthy relationships free from sexual exploitation. PRAY for the youth in our churches and communities and for an end to child sexual exploitation and trafficking."

Meeting was called to order by Anthony Nemcek and the mission statement was read.

Unfinished Business

* Pastor's Report-a printed report was provided. A few things he noted was the upcoming open house held at the Parsonage on Feb 16th from 12-3pm. *Missions - First Choice Clinic collection going until March 9th. Following the Annual Meeting, we will be supporting EPES rather than a specific missionary. It was mentioned that there may be a possibility for a mission trip to Chile.

*Stewardship – The committee will be meeting in the next couple months to plan for the year ahead.

*Personnel – Emily Thoms has fully taken over the role of financial secretary. Any questions having to do with finance should be directed to her using the same email they used to reach Rebecca.
